This program's focus is on proper investigation techniques for motor vehicles as outlined in NFPA Fire Code 921- Guide for Fire and Explosion Investigations, chapter on Motor Vehicle Fires.

Every applicant must meet the requirements of the National Certification Board and must pay an additional \$75.00\* fee. (This is a \$50 discount off the regular fee).

The **CVFI examination** will be offered at the end of this NAFI sponsored training program on September 21. In order to take the examination, the applicant must be a member of NAFI and a CFEI and must submit a completed CVFI application to the NAFI Office. Every applicant must meet the requirements of the National Certification Board and must pay an additional \$75.00\* fee.

Registrants may sit for both exams.
