International Association of Fire Investigators Fellow of the IAFI Application Process

The Fellow (F-IAFI) designation is available to those members of the IAFI, with superior expertise, education, experience, service to the fire investigation profession, and a position of respect within the fire investigation community. An applicant can apply for the F-IAFI designation by choosing one of the following options. All applicants must already be full members of the IAFI and not affiliate members.

Option 1

Criteria (all must be met):

- IAFI Full Member
- Bachelor or Post Graduate Degree from an accredited college or university in a Fire Investigation related field. Accepted degrees: Fire and Safety Engineering Technology, Fire Science, Fire Protection Engineering, Engineering Technology, Science, Applied Science, and Criminal Justice.
- Hold the CFEI designation
- Minimum of 5 years of full time investigation experience as a CFEI

Application package:

- 1. Complete application and attach current CV or Resume.
- 2. Submit a Professional Review Report
- 3. 3 Letters of Recommendation from other Fire Investigation professionals.
- 4. Application fee of \$175 USD

Option 2

Criteria (all must be met):

- IAFI Full Member
- Hold the CFEI designation
- Minimum of 15 years of full time investigation experience as a CFEI

Application package:

- 1. Complete application and attach current CV or Resume.
- 2. Submit a Professional Review Report
- 3. 3 Letters of Recommendation from other Fire Investigation professionals.
- 4. Application fee of \$175 USD
- 5. Fire investigation related paper. Research must be within the previous 3 years.
 - a. Submission of abstract
 - b. Approval of abstract by NAFI/IAFI Board of Governors
 - c. Submission of final paper article. Paper requirements will be sent upon abstract acceptance.

"Professional Review Report":

Professional Review is the final process by which a judgment for F-IAFI is made. This process allows the evaluator insight into how the applicant applies the knowledge and skills they have acquired through NFPA 921 based fire investigations.

Format and Submission Details

- 3 detailed summarized investigations showing (with citations) on how the principals of NFPA 921 were used in the investigation. It is not necessary to provide every detail, provide enough to show that the principals of NFPA 921 were used and how they were used in the investigation. It is your duty to show evidence that your investigation meets and follows NFPA 921, the evaluator will not make any assumptions as to your reasoning.
- The report should be typed or printed on standard letter sized paper, single-sided only and no more than 15 pages long.
- Must include some supporting documentation: photos, diagrams, graphs, etc. Do not send originals, as they will not be returned to you.
- The report should be written in the first person singular. The evaluators are interested in what you have done and what your role was in the investigation.
- The report must be your own work and reflect investigations that you had a significant role in.
- Case specific details should be redacted or altered to preserve the anonymity of your clients but you
 are encouraged to still gain permission from employer and/or client.
