Vehicle Fire Investigation Training Program Lexington, KY

The **Vehicle Investigation Training Program** is designed to meet the training requirements for the Certified Vehicle Fire Investigator Certification Program established by the National Certification Board. The investigation of fires and explosions in motor vehicles is a specialized aspect of fire investigation requiring specific knowledge and expertise.

This program's focus is on proper investigation techniques for motor vehicles as outlined in NFPA Fire Code 921- Guide for Fire and Explosion Investigations, chapter on Motor Vehicle Fires.

Registration for Program

The registration fee for the four-day Vehicle Fire, Arson & Explosion Investigation Science and Technology Seminar is \$850.00. NAFI is offering a single discount for registrants meeting one of the following criteria: \$50.00 discount for two or more registrations from the same company OR \$100.00 discount for current NAFI members. Food, transportation, and lodging are not included in the registration fee. Course materials on a thumb drive are included.

CFEI and CVFI Examinations

The **CFEI examination** will be offered by the National Certification Board in conjunction with this NAFI sponsored training program on September 18. In order to take the examination, the applicant must be a member of NAFI and must submit a completed CFEI application to the National Office. Every applicant must meet the requirements of the National Certification Board and must pay the \$75.00 CFEI Application fee. (This is a \$60 discount off the regular fee).

The **CVFI examination** will be offered at the end of this NAFI sponsored training program on September 18. In order to take the examination, the applicant must be a member of NAFI and a CFEI and must submit a completed CVFI application to the NAFI Office. Every applicant must meet the requirements of the National Certification Board and must pay the \$75.00 CVFI Application fee.

Registrants may sit for both exams during the program.
